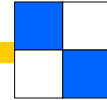

Forget the snow and bring the family!

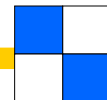
Teams or individuals are asked to raise funds in

our community.

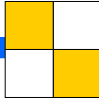
VFJ helps victims cope with trauma and grief,

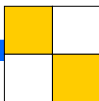
